## Personal Statement (1-page maximum)

Dear members of Region VIII,

I would like to apply for the position of Chair-Elect on NCURA's Region VIII Executive Committee. Being a proud member of NCURA since 2015 and having attended four inspiring Annual Meetings and several interesting NCURA workshops, I would like to give something back and serve as a volunteer. The excellent quality of the events and materials produced by NCURA and the multiple networking occasions are unmatched and helped me a lot in my profession as research administrator. Besides, always having the feeling of being welcome and looked after is what makes this warm organization so unique.

Representing the Region VIII members while following the missions and reaching the goals of NCURA is what I would like to focus on now. I have developed my leadership skills by managing the US and international grant support at KU Leuven Research and Development, the Tech Transfer Officer of KU Leuven (Belgium), both pre and post award and I have trained several colleagues in these areas. I have set up internal procedures and management systems for compliance and I know perfectly what the challenges are for a foreign organization applying for US or other international funding. Today, KU Leuven accommodates 50,000 students, spread across the various campuses in Leuven and elsewhere in the country. The University and University Hospitals in Leuven each employ almost 10,000 people. For research, KU Leuven ranks among the world's finest.
